Sub:- Standard Operating Procedure to prevent the transportation/movement of Cash/bullion/liquor/drugs/contraband goods/goods for freebies through all aeroplanes/helicopters operating from/ to state airports/airstrips/helipads during the election process.

- 1. Reference is made to -
 - (a) This department letter number 827/DIR/AVI/GOCG/2023 dated 06.09 2023.
 - (b) This department letter number 929/DIR/AVI/GOCG/2023 dated 29.09 2023.
 - (c) Letter of Office of the Chief Electoral office, File number 21/Four/Lo.Sa.Chu./ EEM/2024/1550, Raipur dated 26.02.2024, and
 - (d) Letter of Office of the Chief Electoral office, File number 21/Four/Lo.Sa.Chu./ EEM/2024/1902, Raipur dated 12.03.2024.
- 2. BCAS, vide their Circulars (4/2019 and 26/2005), Office Memorandums (OM dated 03.07 2013 and Addendum to OM dated 04/10/2013); has laid down detailed procedures related to aviation activities during election period (all copies enclosed for ease of reference).
- 3. Based on these instructions and guidelines, Standard Operating Procedure (SOP) on the subject is enclosed for strict compliance. Airport Directors of Bilasa Devi Kevat Airport, Bilaspur, Maa Danteshwari Airport, Jagdalpur Maa Mahamaya Airport, Ambikapur and Jindal Airport Raigarh need to adhere to the instructions relevant to licensed airports. District Collectors of rest all the airstrips of State (Balrampur, Jashpur, Korba, Nandini etc.) and all helipads would provide landing permission in advance for operations of any helicopters/aeroplanes in their jurisdictions. Information regarding such movement to enforcement / security agencies should be simultaneously provided for their necessary action.
- 4. Besides, directions and guidelines issued by MHA on various subjects/ issues related to conduct of activities during election period (pages number 89 to 118- refer letter at Para I above) may be referred to for any clarifications needed. Action by external concerned agencies as per BCAS guideline are enumerated for information.
- 5. All necessary measures such as deployment of suitably trained manpower and adequate resources for compliance of instructions & guidelines/monitoring various aspects related to election period needs to be made. Designated task specific areas under CCTV coverage to be earmarked with suitable recording facilities. Alternate arrangements as and when required to fulfill the instruction in letter and spirit needs to be ensured in case of any deficiency arise in resources /manpower. Stipulated documentation/video recording, timely reporting of information and preservation of data for stipulated period needs to be ensured. A telephone directory of required contact number should be available with all concerned.
- 6. This is for a strict compliance.

SUBJECT-STANDARD OPERATING PROCEDURE TO PREVENT THE TRANSPORTION OF UNAUTHORIZED ARMS, CONTRABAND GOODS AND SUSPICIOUS MONEY/ BULLION THROUGH STATE AIRPORTS/ AIRSTRIPS/ HELIPADS/ PASSENGERS DURING THE ELECTION PROCESS IN THE STATE OF CHHATTISGARH BY SCHEDULED/NON SCHEDULED/ PRIVATE CATEGORY/ GENERAL AVIATION/ STATE OWNED HELICOPTER/ AEROPLANE

Election Commission of India (ECI) has directed to prepare a standard operating procedure for prevention of transportation/movement of unauthorized arms, contraband goods, or large sums of cash/bullion through Scheduled/Non Scheduled/ Private Category/ General Aviation/ State Owned Helicopter/ Aeroplane should be prevented.

It is hereby directed that the following measures shall be taken while keeping vigil over the baggage/passengers at airstrips/helipads of the States going for the poll, or of those boarding such helicopter/aeroplane to the poll bounds States:

Section-I - Commercial Airports

1. Checks at Commercial Airports

- a. Procedures to be followed at pre-embarkation chicks points:
 - (i) During the election process, all rules and procedures about frisking and checking of persons and baggage should be strictly enforced without any exception. All passengers (excepting those who are exempted under the Rules) and all the baggage (except exempted), boarding any aircraft/helicopters including commercial/chartered flights will pass through the pre-embarkation security checks area of operational airports of the State going for the Poll.

Action by: Airline Security Staff / APSU Screener Staff

(ii) No prior permission for landing or take-off of chartered aircraft/ helicopters at commercial airports shall be required from District Election Officer (DEO) or Returning Officer (RO). The Air Traffic Control (ATC) shall inform the Chief Electoral Officer (CEO) of the State and the DEO of the district, including all flight details (as per Annex-A) as early as possible, preferably before a suitable time to allow them to attend the flight.

Action by: ATC / Terminal Manager

(iii) During the election process, the ATC shall keep a record of all such chartered aircraft/ helicopters, landing and taking off from commercial airports, time of landing, time of take-off and passenger manifest, route plan, etc. The ATC shall make a copy of this information available to the CEO of the State concerned and to the DEO of the district, in which the airport is located within 3 days, after the date of landing / take off and the CEO/DEO shall make such information available to the Expenditure Observer for making necessary verification during inspection. The ATC shall also make the record available for inspection by Expenditure Observer whenever required.

Action by: ATC



(iv) All baggage, including hand baggage of persons/passengers (not exempted under the Rules) but permitted to avail the facility of vehicle for going up to aircraft shall also be screened by APSU staff without any relaxation.

Action by: Airline security staff / Nominated APSU staff

(v) The APSU staff on detection of cash exceeding Rs.10 lakhs or bullion, weighing 1kg or more in the baggage of aircraft, flying to or from the Poll bound State, shall instantaneously report to the Income Tax Department.

Action by: Chief Airport Security Officer

- (vi) The Income Tax Department, on receipt of information shall make necessary verification as per the Income Tax Laws and take necessary measures. If no satisfactory explanation is given, they shall also inform the Election Commission / Chief Electoral Officer / District Election Officer concerned before the release of any such cash or bullion.
- (vii) The law enforcement agencies, like CISF, State Police, and Income Tax Department shall develop their internal Standard Operating Procedure (SOP) in such a way that the entire event right from detection to seizure or release at the airport is captured by Video Camera. For this purpose, the CCTVs shall be installed in all commercial airports in the interrogation chambers of law enforcement agencies including the Income Tax Department. Such recording of CCTV / Video Camera shall be preserved with Authority for a period of 3 months and when required, be made available to the Election Commission / CEO.

Action by: Enforcement Agencies

- b. Procedures to be followed for disembarking passengers of chartered / state-owned aircraft
 - (i) All passengers, crew members, and other individuals along with their baggage shall be de-planed into a designated non-sterile area of an operational airport. The duty Officer in the ATC will direct the aircraft to the above area and at the same time inform APSU about it.
 - (ii) The Chief Airport Security Officer (CASO) of Bilaspur and Jagdalpur airports will ensure that arriving persons from the aircraft do not trespass into a sterile area of the airport.
 - (iii) In case there is no designated non-sterile area at an operational airport for deplaning of the passengers and the passengers are deplaned in a sterile area, the following security measures shall be taken to prevent mixing of such passengers with security-cleared passengers of the other commercial flights:
 - a. CASO shall provide necessary security coverage so that passengers disembarking into the sterile area of the airport do not mix up with security-cleared passengers of commercial flights
 - b. Duty Officer in the ATC shall inform APSU about the arrival of a general aviation flight / chartered flight. On receipt of this information, the CASO will send an armed escort to reach the aircraft before deplaning the passengers.
 - c. If there is more than one parking bay at an airport the aircraft will be parked in a bay other than the one used for parking commercial flights.
 - d. The armed escort of APSU will escort the passengers of the aircraft to the land side of the airport.

 Action by: ATC / CASO



Section -II

2. Checks at Non-commercial Airports/ Helipads:

(i) At remote/uncontrolled airports/helipads, the flying squad or police authorities of the State/UT in coordination with the pilot of the aircraft shall carry out the screening/physical checking of all baggage coming out of the craft (except the handheld purse by the ladies), Any unauthorized arms, contraband goods, cash exceeding (limits specified)belonging to any candidate or the agent or party functionary shall be investigated and considered for seizure. as per order of the Hon'ble Supreme Court in Election Commissioner Vs Bhagyoday Janparishad & Ors. WP No. 231/2012, dated 09.11.2012. However, it is clarified that frisking of the body of any passenger shall not be done at the time of disembarkation at such remote uncontrolled airports/helipads unless there is specific information aboutunauthorized arms or contraband goods, etc. being carried by the person.

Action by: Enforcement Agency & Pilot

(ii) At remote/uncontrolled airports/ helipads, an application will have to be made either by the candidate or by the political party to the CEO/ DEO concerned, at least 24 hours before landing, mentioning the details of the travel plan, place of landing in the district and names of passengers in the aircraft/ helicopters so that CEO/ DEO can make adequate arrangements for security, law and order issues and also to make available the coordinates of the helipad. On receipt of such application. CEO/ DEO shall issue permission on the same day on a priority basis.

Action by: Electoral Authority

(iii) Every candidate shall also inform the Returning Officer concerned in writing within five days after the landing of the aircraft/ helicopter in his constituency about the hiring charges paid/payable to the company owning/leasing the aircraft/ helicopter, the names of passengers, and the name of the political party. (if the party has borne the expense for the hiring)

Action by: Aircraft Operator

- (iv) Passengers, crew, and baggage to be transported in General Aviation/Chartered/private aircrafts and aircrafts owned or hired by state governments shall be emplaned through the normal pre-embarkation security check procedure as applies to scheduled flights. Similarly normal disembarkation channels shall be followed and exit of such passengers and baggage shall not be allowed through any other gate of the airport. Movement of exempted category passengers is to be coordinated in advance for smooth passage but their hold baggage will be screened.
- (v) Baggage (except the handheld purse or pouch by any passenger) of arriving passengers. Crew in respect of General Aviation/Chartered/Private aircraft and aircraft owned or hired by state governments shall be screened/physically checked randomly by CISF/ASG or State Police wherever deployed. The X-BIS may be provided on arrival by the airport operator CISF/ASG shall arrange to deploy additional manpower, If necessary

Action by: CSO/CASO/APSU

(vi) It will be the responsibility of the District Magistrate/SP to prevent the transport of unauthorized arms, contraband goods, and suspicious money/bullion in General Aviation! Chartered/ Private aircraft and aircraft owned or hired by state governments operating to/from remote/ uncontrolled airports/helipads to poll-going states during the election process. The guidelines are to be strictly adhered to and the above instructions will remain in force till the end of the poll process in the states.

Action by: District Magistrate/SP



Section -III General Aviation Operations and Chartered Aircraft/Helicopters Operation.

- a. Following points to be adhered to general aviation operators and charted aircraft/helicopter operation.
 - (i) Whenever there is any notification by the Government banning and/or alerting for carriage of high volume cash/currency notes, bullion, or movement of other valuables etc. 'for a considerable period, Aircraft Operator or Pilot-in-Command shall be responsible for preventing transport of contraband goods and suspicious money/bullion or movement of other valuables in General Aviation/Chartered/Private Aircrafts operating to and from remote/uncontrolled/controlled airports/helipads during such notification period.

Action By: Aircraft Operator/Pilot-in-command

(ii) If detected during the prescribed security search before embarkation of the aircraft, the pilot-in-command/Co-pilot will intimate such suspicious carriage of contraband goods and suspicious bullion to the ATC of the departing airport and the landing airport as well. The duty Officer in the ATC shall inform APSU/ ASG about the arrival/departure of a general aviation/chartered/private aircraft. Upon receipt of this information, the Chief Airport Security Officers/Aircraft Operators/Pilot-in-command/In-charge local police will coordinate with the appropriate authorities for their further necessary action.

Action By: Aircraft Operator/Pilot-in-command/ CASO

(iii) The Air Traffic Control (ATC) in commercial airports shall inform the CEO of the State, about the travel plan of private aircraft or helicopters as early as possible, preferably before a substantial time to enable them to attend the flight. No prior permission for landing or take-off of aircraft (including fixed-wingaircraft) and helicopters at commercial airports shall be required from District Election Officer (DEO) or Returning Officer (RO).

Action By: ATC

(iv) However, during the election process the ATC shall keep a record of all such private aircraft or helicopters as per Annex-A. The ATC shall make a copy of this information available to the Chief Electoral Officer of the State concerned within 3 days, after the date of landing/ take off and the CEO shall make such information available to the Expenditure Observer for making necessary verification during inspection. The ATC shall also maintain and provide the record available for inspection by Expenditure Observer whenever required.

Action By: ATC/CEO/DEO

Section -IV Other measures are as follows-

During the election process, to curb the use of black money the services of the Income Tax Department may also keep a strict vigil over the movement of cash through all airports in the country/poll-going states. This will be apart from the regular duty undertaken by the APSU. Accordingly, all cooperation shall be extended to the Income Tax Department/CISF in this regard to facilitate their operation including checking out and surveillance activity as per law in all the airports in the country of the poll-going states. The following instructions are to be followed additionally:-

(i) Passengers, Crew, and baggage to be transported in General Aviation Chartered Private aircraft and aircraft owned or hired by state governments shall be emplaned through the normal pre-embarkation security check procedure as applies to scheduled flights. Similarly normal disembarkation channels shall be followed and exit of such passengers and baggage shall not be allowed through any other gate of the airport Movement of exempted category passengers is to be coordinated in advance for smooth passage but their hold baggage will be screened.

Action By: CASO

(ii) APSU on detection of cash, exceeding Rs.10 lakhs or bullion, weighing 1 kg or more in the baggage of passengers/staff/crew of aircraft, flying to or from the Poll bound State, shall be instantaneously reported to the Income Tax Department.

Action By: Airline staff/CASO/Income Tax



(iii) Baggage (except the handheld purse or pouch by any passenger) of arriving passengers, crew in respect of General Aviation/Chartered Private aircraft, and aircraft owned or hired by state governments shall be screened/physically checked randomly by APSU. The X-BIS may be provided on arrival by the airport operator. APSU shall arrange to deploy additional manpower, If necessary for this duty.

Action By: CASO

(iv) APSU will ensure that disembarking passengers do not mix up with the security-cleared passengers/employees in the airside.

Action By: CASO/ Terminal Manager

(v) The disembarking occupants will be transported under escort to the land side of the airport through a designated gate so that mix-up with security-cleared passengers/employees in the airside is avoided. In case, the number of passengers is large, the airport operator shall arrange for a suitable vehicle to carry the passengers to the land side of the airport. Likewise, the cargo/baggage from the aircraft shall also be transported under escort to the land side.

Action By: CASO

(vi) All passengers, crew members, and other individuals boarding the aircraft shall be emplaned only through the security hold area (SHA) of the airport, after they have been subjected to pre-embarkation security checks prescribed by BCAS.

Action By: CASO

(vii) Airport Operators manning the In-line Baggage Screening System (IBSS) and the aircraft operators engaged in the screening of baggage through standalone X-BIS shall report the detection of unauthorized arms to police and suspicious money/bullion to Income Tax Officer(s) posted at the airports in poll going states without any delay.

Action By: Airlines Security/CASO/Income Tax

All concerned are requested to ensure that the above directions are strictly complied with under intimation to this office for necessary action/compliance.



- 2. You are requested to obtain a small write up (half or full page) on particular seizure of more than Rs. 1 Crore from the concerned enforcement agency and furnish the same along with the progressive report to the Commission.
- 3. You are also requested to ensure that the process of onboarding of DEOs, Nodal officers of enforcement agencies, DLBCs and Banks on ESMS software is complete by 28th February, 2024. The ESMS recording of data of interception and seizure by enforcement agencies must start reflecting from 1th March, 2024. As per Commission's SOP dated 29th May, 2015, function of Flying Squads (FSs) and Static Surveillance Teams (SSTs) shall start from date of announcement of elections and date of notification of elections respectively. The placing of Flying Squads (from the date of announcement of election)/Static Surveillance Teams (from the date of notification) on the software will be done as per timelines. Except for FSs/SSTs, other agencies must report interception and seizures from 1th March, 2024 on daily basis. The ESMS recording of interception by FSs/SSTs shall start as per timelines mentioned above.

I am directed to state that as you are aware during election period contesting candidates, star campaigners and other leaders/members of political parties use aircrafts/helicopters for campaigning across the poll bound States. There are numbers of airports/airstrips/helipads in poll bound States of Chhattisgarh, Madhya Pradesh, Mizoram, Rajasthan and Telangana, which are under control of State Govt. Apart from State owned helipads, Chhattisgarh has 02 airports (Bilaspur Airport, Jagdalpur Airport) under control of State Govt. out of total 03 airports in the State. Mizoram has 01 airport (Lengpui Airport) under control of State Govt. out of total 02 airports in the State.

- 2. The Commission has felt requirement of a Standard Operating Procedure (SOP) on the same line as issued by Bureau of Civil Aviation (BCAS) vide their letter no. CAS-7(15)/2012/Div-I (Election), dated 03.07.2013 and 11.10.2013 (copy enclosed, also available at Annexure G4 and G5 in Compendium of Instructions on Election Expenditure Monitoring (August, 2023) for the airports/airstrips/helipads which are under control of the State Govt. to prevent transport of unauthorised arms, contraband goods and suspicious money/bullion through these airports/helipads during election process.
- 3. You are requested to bring it to the notice of the department concerned of the State Govt. to devise an SOP for the airports/airstrips/helipads accordingly, which are under control of the State Govt., keeping in view of forthcoming General Elections to Legislative Assemblies of Chhattisgarh, Madhya Pradesh, Mizoram, Rajasthan and Telangana, 2023.
- 4. A copy of the instruction issued in this regard be endorsed to the Commission in a fortnight of receipt of this letter.

Subject: Modified Standard Operating Procedure to prevent transport of unauthorized arms, contraband goods and suspicious money/bullion through airports during election process-matter reg.

Ref. OMs of even no. dated 08.04.2011 and dated 14.02.2012

Reports are received that during the process of elections, unauthorized arms, contraband goods or large sum of cash/bullion are often transported through chartered aircraft/helicopters/passengers of commercial airlines to the poll bound States. The Election Commission of India is concerned about such incidents, which may disturb the level playing field during the election process.

2. Therefore, as per request of the Election Commission of India, it is hereby directed that the following measures shall be taken, while keeping vigil over the baggage/passengers at commercial airports and in non-commercial airs(rips/helicopters of the States, going for poll of those boarding such aircrafts to the poll bounds States:

Pre-embarkation checks at Commercial Airports:

- (i) During election process, all rules and procedures with regard to frisking and checking of persons and baggage should be strictly enforced without any exception. All passengers (excepting those who are exempted under the Rules) and all the baggage (excepting that which is exempted under the Rules), boarding any aircraft/helicopters including commercial/ chartered flights will pass through the pre-embarkation security checks area of operational airports of the State going of Polls.
- (ii) No prior permission for landing or take off of chartered aircrafts (including fixed wing aircrafts) and helicopters at commercial airports shall be required from District Election Officer (DEO) or Returning Officer (RO). The Air Traffic Control (ATC) in commercial airports shall inform the Chief Electoral Officer (CEO) of the State and the DEO of the district, in which the airport is located, about the travel plan of chartered aircrafts or helicopters as early as possible, preferably half an hour in advance.

- (iii) However, during election process, the ATC shall keep record of all such chartered aircrafts or helicopters, landing and taking off from commercial airports, time of landing, time of take off and passenger manifest, route plan etc. The ATC shall make a copy of this information available to the CEO of the State concerned and to DEO of the district, in which airport is located, within 3 days, after the date of landing/take off and the CEO/DEO shall make such information available to the Expenditure Observer for making necessary verification during inspection. The ATC shall also make the record available for inspection by Expenditure Observer whenever required.
- (iv) All baggage, including hand baggage, of persons/passengers (not exempted under the Rules) but permitted to avail the facility of vehicle for going up to aircraft shall also be screened by CISF/State/UT police without any relaxation.
- (v) The CISF or police authorities of the State or Union Territory on detection of cash, exceeding Rs.10 lakhs or bullion, weighing I kg or more in the baggage of aircrafts, flying to or from the Poll bound State, shall instantaneously report to the Income Tax Department.
- (vi) The Income Tax Department, on receipt of information shall make necessary verification as per the Income Tax Laws and take necessary measures if no satisfactory explanation is given. They shall also inform the Election Commission / Chief Electoral Officer / District Election Officer concerned, before release of any such cash or bullion.
- (vii) The law enforcement agencies, like CISF. State Police and Income Tax Department shall develop their internal Standard Operating Procedure (SOP) in such a way that the entire event right from detection till seizure or release at the airport is captured by close circuit TVs/ Video Camera. For this purpose the CCTVs shall be installed in all commercial airports in places where the cash/ bullion is detected counted/ seized and also in the interrogation chambers of the law enforcement agencies including Income Tax Department Such recording of CCTVs / Video Camera shall be preserved with the Airport Operator/ Authority for a period of 3 months and when required, be made available to the Election Commission/CEO.

Checks at Non-commercial Airports/helipads:

(viii) At remote/uncontrolled airports/helipads, the flying squad or police authorities of the State/UT in coordination with pilot of the aircraft shall carry out the screening/physical checking of all baggage coming out of the craft (excepting the handheld purse by the ladies). Any unauthorized arms, contraband goods, cash exceeding Rs.50,000/- belonging to any candidate or agent or party functionary shall be investigated and considered for seizure

as per order of Hon'ble Supreme Court in Election Commissioner vs Bhagyoday Janparishad & Ors. WP No. 231/2012, dated 09.11.2012. However, it is clarified that frisking of body of any passenger shall not be done at the time of disembarkation at such remote uncontrolled airports/helipads, unless there is specific information about unauthorized arms or contraband goods, etc., being carried by the person.

- (ix) At remote/uncontrolled airports and helipads, application will have to be made either by the candidate or by the political party to the DEO concerned, at least 24 hours before landing, mentioning the details of travel plan, place of landing in the district and names of passengers in the aircrafts/helicopters so that DEO can make adequate arrangements for security, law and order issues and also to make available the coordinates of the helipad. On receipt of such application, DEO shall issue permission on the same day on priority basis.
- (x) Every candidate shall also inform the Returning Officer concerned in writing within five days after the landing of aircraft/helicopter, in his constituency about the hiring charges paid/payable to the company owning/leasing the aircraft/helicopter, the names of passengers and name of the political party. (if the party has borne the expense for the hiring)
- 3. All concerned are requested to ensure that the above directions are strictly complied with under intimation to this office.

ADDENDUM TO OFFICE MEMORANDUM DATED 04/10/2013

Subject: General Elections to the Legislative Assemblies of NCT of Delhi, Chhattisgarh, Rajasthan, Madhya Pradesh and Mizoram-2013- reg.

Reference is invited to this office O.M. of even number dated 04/10/2013 regarding implementation of Modified SOP to prevent transport of unauthorized arms, contraband goods and suspicious money/bullion through airport located during current election process in the poll going states. The following instructions are to be followed additionally:-

- (xi) Passengers, crew Aviation/Chartered/Private aircrafts and aircrafts owned or hired by state governments shall and baggage be emplaned through the normal pre-embarkation security check procedure as is applicable to scheduled flights. Similarly normal disembarkation channel shall be followed and exit of such passengers and baggage shall not be allowed through any other gate of the airport. Movement of exempted category passengers is to be coordinated in advance for smooth
- (xiii) Baggage (except the handheld purse or pouch by any passenger) of arriving passengers, crew in respect of General Aviation/Chartered/Private aircrafts and aircraft owned or hired by state governments shall be screened/physically checked randomly by CISF/ASG or State Police where deployed. The X-BIS may be provided on arrival by the airport operator CISF/ASG shall arrange to deploy additional manpower, If necessary for
- (xiv) Airport operators manning the In-line Baggage Screening System (IBSS) and the aircraft operators engaged in screening of baggage through stand alone X-BIS shall report the detection of an unauthorized arms to police and suspicious money/bullion to Income Tax Officer(s) posted at the airports in poll going states without any delay; and
- (xv) It will be the responsibility of District Magistrate/SP to prevent transport of unauthorized arms, contraband goods and suspicious money/bullion in General Aviation/ Chartered/ Private aircrafts and aircraft owned or hired by state governments operating to/from remote/ uncontrolled airports/helipads to poll going states during election process. The guidelines are to be strictly adhered to and the above instructions will remain in force till end of the poll process in the states.
